Artwork

- All work must be appropriate for viewers of all ages
- **Size Limit:**
 - 2D art - under 2'w x 4'h (ready to hang securely, with wire)
 - 3D art - under 2'w x 2'd x 7'h (freestanding, must be stable)
- **Weight limit:** Maximum 20 pounds

Entry Fee: Entry fees are non-refundable and must be paid by either cash, check, or credit/debit card. \$30 for one entry; \$25 for a second entry (limit 2)

Sales: Work may be for sale or listed as not for sale. The gallery will not charge a commission on artist sales but will deduct a 6% *credit card fee* from any sales paid by credit/debit card.
